



Volunteer Release and Waiver of Liability Form

This Release and Waiver of Liability (the "Release")

executed on _____ (date mm/dd/yyyy) by _____ ("Volunteer")

releases The Blairstown Enhancement Committee ("The BEC"), a nonprofit corporation organized and existing under the laws of the State of New Jersey and each of its directors, officers and agents. The Volunteer desires to provide volunteer services for The BEC and engage in activities related to serving as a volunteer.

Volunteer understands that the scope of Volunteer's relationship with The BEC is limited to a volunteer position and that no compensation is expected in return for services provided by Volunteer; that The BEC will not provide any benefits traditionally associated with employment to Volunteer; and that Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of Volunteer's services to The BEC.

1. Waiver and Release: I, the Volunteer, release and forever discharge and hold harmless The BEC and its successors and assigns from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from the services I provide to The BEC. I understand and acknowledge that this Release discharges The BEC from any liability or claim that I may have against The BEC with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to The BEC or occurring while I am providing volunteer services.

2. Insurance: Further I understand that The BEC does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of The BEC beyond what may be offered freely by The BEC in the event of injury or medical expenses incurred by me.

3. Medical Treatment: I hereby release and forever discharge The BEC from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with The BEC.

4. Assumption of Risk: I understand that the services I provide to The BEC may include activities that may be hazardous to me. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and release The BEC from all liability.

5. Photographic Release: I grant and convey to The BEC all right, title, and interests in any and all photographs, images, video, or audio recordings of me or my likeness or voice made by The BEC in connection with my providing volunteer services to The BEC.

6. Other: As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of New Jersey and that this Release shall be governed by and interpreted in accordance with the laws of the State of New Jersey. I agree that in the event that any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
